

EUGÊNIO PACELLI DE OLIVEIRA

Professional Background

Mr. Pacelli completed his Law degree at the Faculty of Law of the Federal University of Minas Gerais in 1989. Six months later, he joined the Attorney General's Office of the State of Minas Gerais after passing a public competitive examination. He served as a State Attorney for Minas Gerais from 1989 to 1992.

In 1993, Mr. Pacelli entered the Federal Public Prosecutor's Office (*Ministério Público Federal*) through a national-level public competitive examination. He was assigned to the Federal Prosecutor's Office in Minas Gerais from 1993 to 2007, also holding the position of Regional Electoral Prosecutor in that state from 2002 to 2007.

In 2007, Mr. Pacelli was promoted to the position of Regional Prosecutor of the Republic in the Federal District, acting at the appellate level before the Federal Regional Court in Brazil's capital.

Between 1998 and 2004, Mr. Pacelli completed his Master's and Doctoral studies, publishing his Master's dissertation in 2000 and his doctoral thesis in 2004¹, as will be further detailed below.

In 2008, Mr. Pacelli was part of the Commission of Jurists established by the Federal Senate, serving as its General Rapporteur. The Commission's mandate was to draft a new Brazilian Code of Criminal Procedure. The work was completed the following year and converted into Law Project (PL) 156, which was swiftly approved by the Senate. Since 2010, the PL has been under review in the House of Representatives.

Mr. Pacelli left the Federal Public Prosecutor's Office in 2014, when he founded the law firm Eugênio Pacelli Sociedade de Advogados, now *Pacelli e Horta Advocacia e Consultoria*², with offices in Belo Horizonte/MG and Brasília/DF.


He is also a Professor of Criminal Procedure Law in the Master's and Doctoral programs at the Brazilian Institute of Education, Development and Research (IDP), based in Brasília.

Mr. Pacelli is the author of numerous publications in the field of Criminal Law and Criminal Procedure, among which the most notable are *Regimes constitucionais da liberdade provisória* (adaptation of his Master's dissertation, Del Rey Publishing, MG, 2000), *Processo e hermenêutica na tutela penal dos direitos fundamentais* (adaptation of his doctoral thesis, four editions, the first in 2004, Del Rey Publishing, MG, and the latest in 2012, Atlas Publishing, SP), and *Prisão preventiva e liberdade provisória*, co-authored with Domingos Barroso da Costa (Atlas Publishing, São Paulo, 2013), as well as several other collective works, where he has acted as both coordinator and contributing author³.

Finally, we highlight some of Mr. Pacelli's major works, which have gained broad public recognition and acceptance in Brazil's higher courts: *Curso de Processo Penal*, now in its 28th edition, with the first published in 2002 and the latest in 2024 by Lumen Juris Publishing, RJ; *Comentários ao Código de Processo Penal e sua Jurisprudência*, co-authored with Douglas Fischer, now in its 16th edition, JusPodivm Publishing, SP; and *Curso de Direito Penal – Parte Geral*, co-authored with André Callegari, now in its 7th edition, JusPodivm Publishing, SP.
